Adults Entering Employment

EXCEEDS STATE PERFORMANCE MEASURE

856 Adults Sought Employment Opportunities through the SuperJobs Center (all branches).

661 Adults Entered Employment utilizing the services of the SuperJobs Center.

This is equal to a rate of 77.2%.

State standard performance is 77%.

State minimum performance (80% of Standard) is 61.6%.



Adult Retention Rate

MEETS STATE PERFORMANCE MEASURE

After entering employment, the SuperJobs Center seeks to follow Adults for approximately three quarters, providing support to these newly hired workers.

819 Adults Entered Retention Services for the first time in PY 2007.

687 Adults were retained for three quarters in PY 2007.

This rate is 83.9%.

State standard performance is 86%.

State minimum performance (80% of Standard) is 68.8%.



**Adult Average Earnings
EXCEEDS STATE PERFORMANCE MEASURE**

The average earnings for those reporting and verifying their earnings was \$15,051.

The State Standard is \$14,000.

State minimum performance (80% of Standard) is \$11,200.

The general WIA definition of a dislocated worker is “an individual who has been terminated or laid off [through no fault of their own], who has received notice of termination or lay-off at a plant or business which is closing.”



**Dislocated Workers Entering Employment
MEETS STATE PERFORMANCE MEASURE**

338 Dislocated Workers utilized the SuperJobs Center for Employment, Training, and other re-entry services.
276 Dislocated Workers found employment in PY 2007.

This is a rate of 81.7%.

The State Standard is 86%.

State minimum performance (80% of Standard) is 68.8%.



Dislocated Worker Retention Rate
MEETS STATE PERFORMANCE MEASURE

After entering employment, the SuperJobs Center seeks to follow Dislocated Workers for approximately three quarters, providing support to these newly rehired workers.

243 Dislocated Workers Entered Retention Services for the first time in PY 2007.
213 Dislocated Workers were retained for three quarters in PY 2007.

This rate is 87.7 %.
State standard performance is 91%.
State minimum performance (80% of Standard) is 72.8%.



Dislocated Worker Average Earnings
EXCEEDS STATE PERFORMANCE MEASURE

The average earnings for those reporting and verifying their earnings was \$19,270.

The State Standard is \$16,670.
State minimum performance (80% of Standard) is \$13,336.

Youth are defined, under WIA law, as individuals ages 14 – 21.



**Youth Placements (Employment or Education)
EXCEEDS STATE PERFORMANCE MEASURE**

174 Youth (ages 14 – 21) sought assistance from the Emerging Workforce Development Council for employment or educational services.

152 Youth were placed into employment opportunities or educational programs.

This rate is 87.4%.

The State Standard is 61%.

State minimum performance (80% of Standard) is 48.8%.



**Youth Certificates or Diplomas
EXCEEDS STATE PERFORMANCE MEASURE**

190 Youth (ages 14 – 21) sought to receive a certificate or diploma with assistance from the Emerging Workforce Development Council's services.

108 Youth received certificates or diplomas.

This rate is 56.8%.

The State Standard is 41%.

State minimum performance (80% of Standard) is 32.8%.



Youth Literacy and Numeracy EXCEEDS STATE PERFORMANCE MEASURE

49 Youth (ages 14 – 21) sought assistance from the Emerging Workforce Development Council to increase their reading and math skills.

18 Youth made significant progress in their reading and math skills scores.

This rate is 36.7%.

The State Standard is 35%.

State minimum performance (80% of Standard) is 28%.
